### <u>Illness</u>

If a child develops symptoms of an illness, the parent or other designated person will be notified. Parents will also be contacted if the child is involved in a serious accident. If the child needs emergency medical care and the parent cannot be reached, KidsKamp will seek emergency medical care for the child. Permission for this is granted to the camp on the Registration Form.

Parents will need to make arrangements to pick up a sick child as soon as possible after being called. We do not have a sick room at camp. Any person other than the parent picking up a sick child will need to bring identification.

Do not send your child to camp if he/she shows signs of illness or has been running a fever within the past 24 hours. All children must be free of fever, vomiting, or diarrhea for 24 hours without the aide of fever reducing medication, or any other medication before he/she can attend or return to camp.

#### **Medication**

We will give medication only when absolutely necessary at parents' request. Before medication will be given, the parent must provide a written prescription from a doctor. Medicine will only be administered under these conditions:

- 1. All medicine must be prescribed by a physician and in the original container.
- 2. Over the counter medication will only be given as prescribed in writing by the doctor and in the original container.
- 3. All medication must have a written notice of side effects attached to the medication form.
- 4. No aspirin or similar medication (Tylenol, Aleve, etc) will be given to a child for any reason.
- 5. Breathing treatments will not be administered.
- 6. Children requiring epi pens and day to day medication must bring them to camp daily.

# Before / After Care

<u>Before and Aftercare is not available to any child in the 2-yearold program unless prior arrangements are made with the</u> <u>director.</u> All other children enrolled at KidsKamp can use before care at no charge. Aftercare is charged at a rate of \$3.50 per hour, charged in 30-minute increments with a minimum 1-hour charge if camper is put in aftercare at 3:15pm. Aftercare charges are due no later than Monday morning. Any unpaid charges on will incur a \$1 per day / per child late fee until the weekly aftercare charges are paid.

## Payment Policy

KidsKamp strives to offer affordable summer camp for your child, and it is our goal to remain economical. At the same time, we must meet our financial obligations in order to provide this camp for our community. Camp fees are due the Thursday prior to the week of camp. If camp fees are not paid by Monday at drop off, you may NOT leave your child at camp. If you have a special circumstance, that must be discussed with the camp director. KidsKamp accepts cash, check, money order, Venmo and Zelle for payment.

NSF fee is \$25.00. After one NSF check, all remaining camp fees must be paid by cash, credit, debit, or money order. KidsKamp reserves the right to collect the NSF check at any time, (if it is not paid) through electronic draft, re-deposit, or through the District Attorney's Office if necessary.

 Any family experiencing financial difficulties is encouraged to talk with the camp director about other payment options.
